I was putting locks on two bedroom doors and one closet door in preparation for an Estate Sale to keep visitors out of specific areas.

Facts according to notarized documents presented by the Plaintiff:

1. She opened her business in 2019.
2. She closed her business in 2021.
3. She has had no income from the business since 2020.

Here she makes the following statements:

1. If she gets in trouble, I will also get in trouble. 07:42
2. Her lawyer knows everything about her business. 07:49
3. She uses her brothers credit card. 08:06
4. The money that she uses is her dads. 08:35
5. She buys products, but it's really her parents and brother buying the products. I assume she means because she is using their bank cards. 08:54
6. She hasn't bought and sold products for a long time. In 2022 she did a little business. 09:00
7. She can close her business and still do business legally. 09:29
8. She did business after she closed the business mentioning her own credit card and since the other credit cards in her possession (that she uses) are not in her name, she disregards activity on those cards. 09:46
9. It's ok if she does business and says she doesn't do business if she uses their credit cards, and they use their credit cards for themselves to buy products for her business. 09:57
10. They are using their credit cards to buy products through Xia's accounts for themselves. 09:57
11. All the products are being purchased for a Chinese business, not an American business, so the IRS is outside their jurisdiction. (This is the same business she started from here, operated from here, sent products to, and made money with since 2015.
12. She buys and sells products now for THEIR business, not her business. And she doesn't get anything for it. 10:28
13. She withdraws money using their cards from the ATM. 10:32
14. Any money she withdraws is her mom's money. And she gives it to me. 10:38
15. She admits to receiving money and says it's ok because none of it comes from her name. Meaning her name is not on any of the accounts. 11:00
16. She admits to getting ATM money from her moms bank account at the ATM. 11:09
17. All money that comes from the ATM is gift money given to her by her mom. 11:23
18. She didn't do anything wrong because now, the money which she says is money they use to do their own business, the money she gets from ATM's, the money that is not in her name, the money that she can use to still do business without a business after closing her business is tax free because it's gift money. It's not money that is coming back to purchase products to make more sales. 11:28

19. She didn't do business for a long time. Until last year (2023) she had \$4000 credit. The rest of it, is her brothers or whoever the card belongs to, maybe her brother or someone else. And they are using her credit card in her accounts to purchase products. 11:45
20. It's legal for her to help them do business because she's not taking any money. The business that she started, and runs. 12:23
21. Everything she does is legal because she doesn't have a Chinese bank account and the money is now again, just money from her mom. 12:26
22. The money is a gift. 12:35
23. Here she says that while she didn't spend any money from her brother, implying this is totally her brothers business, even though she started a Sole Proprietorship only in her name, now she says I spent that money. I assume this means, during the time she was operating her business, when she contributed more, that money was not her money, but was allowed to her by her brother, who didn't own the business. 12:46
24. Here she is saying she did business in 2022 and 2023, but it was her brothers business. The same business she operated in 2019. 12:49
25. Here she says she kept doing business in 2022 and 2023 but closed it since she wasn't making enough money. 13:25
26. Here she doesn't say no business. She says little business. And also that the credit cards she uses are not her name. Then she says she doesn't have enough money to pay the tax. Then she said she spent \$4000 in her bank card, implying that even in 2024 she is doing business.
27. Then she states how her accounting thinking goes. She accounted for the money that went into and out of her account. She didn't consider all the other accounts she was using.
28. Then she states again how she's using the Chinese accounts but can't claim it because she didn't take any money but then turns around and says she DID take money. But that was gift money.

DAN

So do I.

XIA

Fucking little business in there. And the accounts, the credits cards are not my account either. The credit card over \$10,000 in there spend \$20,000. Even don't have enough money to make. Pay the tax. And then 2023 I spend \$4000 in my bank card.

DAN

You don't have enough money to pay taxes so you didn't report it? That's what you should never say.

XIA

.. money there.. I could report right now. Doesn't matter.

DAN

So do it, because it's illegal.

XIA

Then, I can report any time I want. I want to report this year, ask you, you said no. Don't do it.

DAN

Why would I say no this year?

XIA

You did. I ask you. Do you want to amend it? Because I said that paper to my EA, whatever the volunteer EA . He tried to do in it and you say no and I told him no. And the email still in there from

my school. Everything took him over there. Ask him. He can prove it. And I told him my husband say no. I talk to him.

DAN

I don't care what you're saying right now. I know you're .. do business this whole time. And I know you're lying about it. You can continue to lie about it if you want to.

XIA

Do you know how much in there? How much I make in there? Nothing

DAN

Ok Xia, I already know all the numbers so..

XIA

I already tell them, I make all the account a few months ago sent it to my... probably you already have my statement. I making it. I sent it to the lawyer.

DAN

I don't have anything from you.

XIA

Because I have to do the statement all the bank account, any detail. I already finished it two months ago.

DAN

Great, that's the whole point, it's a lie.

XIA

It's not a lie it come from the account. How much go in, how much go out.

DAN

Ok, we'll see.

XIA

Everything in there and the other credit card, the Chinese credit card is not my business I can't report anything about that because I didn't take any money.

DAN

You did take money. I tell you, there's ATM records. I already told you.

XIA

Yeah ATM I took gift money my parents give to me to do business.

DAN

You see, you just said two different stories. One story is that you didn't take money and the other story is it's a gift. So what story is right?

XIA

It's a gift too, it's not lying. ... \$800 come form the ATM

DAN

One time \$800 or 75 times \$800?

XIA

Even if it's 75 times it doesn't matter.

DAN

It does matter.

XIA

Even the whole year didn't come up make money. In 2023 and 2022. I know how much I get out from there. .. See it.

DAN

Great

XIA

I have this receipt, I have to keep the receipt, I know you take the receipt ... do that. I have to keep it so that IRS .. the people at the IRS can see it.

DNA

They don't need your receipts Xia, they have the ATM documents.

XIA

They can check it. It's an ATM, they can ... account and check it. I need that.

DAN

They don't need your account. They can already check it. They don't need you to say ok you can check it.

XIA

Yeah a Chinese account they can look at it, can see it, can see it's not my name on there.

DAN

It's not the Chinese account that they're looking at. They're looking at whether or not you took money from the ATM, which is in the ATM records.

XIA

Yeah the Atm records is from the Chinese account.

DAN

No it's not, it's from the American ATM system.

XIA

Yeah it's from the ATM, Chinese ATM system from the Chinese account.

DAN

Yes

XIA

It's not my name. The Chinese account is not my name. You got to know about that.

DAN

But it is you taking the money.

XIA

Yeah, I'm taking the money it's from my parents give to me.

DAN

That's where they are going to start to ask questions.

Yeah my parents give it to me. I'm happy to ask the question.

DAN

Great

Speaker 1

I'm happy to ask the question.

DAN

We'll see how much it is.

Yes, how much, doesn't matter.

How much does matter.

Even over \$100,000 is only, probably is only, I don't know how much is \$800 time twelve...

DAN

\$9600, \$800 a month probably, and give it to you.

No you didn't give it to me.

I have all those records too.

Speaker 1

I did, I have the records. I give you checks.

DAN

Ok, we'll see.

Speaker 1

You'll see.

DAN

You can laugh all you want, the truth is you sold a ton of products and you didn't report sales.

I didn't sell anything.

DAN

You didn't sell anything?

Speaker 1

I have my little thing in there on my name, and my credit card I ship over there, didn't make any money.

DAN

Yeah, it's not about your credit card. It's about your accounts.

And another card, is my brothers card

DAN

It's about all your accounts.

Speaker 1

Yep, in my accounts, they have to use it. ... already there.

DAN

Even your ebates account.

Speaker 1

Yep, it already in there.

DAN

Already where?

Speaker 1

It's already in there with my brother.. with my brother doing business and that credit card in there so I keep in there.

DAN

It's not about your credit card

Speaker 1

Yes

DAN

It's about your accounts.

Speaker 1

It doesn't matter.

DAN

How much money did Ebates give you? You do have Ebates. You receive checks from Ebates.

Speaker 1

I don't have Ebates.

DAN

You do have ebates. You receive checks from ebates.

Speaker 1

I don't receive any checks from Ebates. What are you talking about?

DAN

What's the one that sends you checks when you get money back from buying things online?

Speaker 1

I don't get any check. Ebate what are you talking about?

DAN

Ok, there's another lie.

Speaker 1

You said you .. ebates?

DAN

Ebates

Speaker 1

I don't have ebate check.

DAN

What's the check then?

Speaker 1

I don't have a check from ebay.

DAN

What's the check you get after you buy stuff online and they give you money back?

Speaker 1

What, buying stuff and they give me money back?

DAN

Yeah, called Ebates.

Speaker 1

Called Ebay? Ebay.com?

DAN

Not ebay.com, Ebates.

Speaker 1

Oh Ebate.

DAN

Yeah

Speaker 1

Oh, report.. use them system to do it so they give me cash back.

DAN

Yeah. How much? 1% of what value?

Speaker 1

What percent of what value..

DAN

So there's another way to calculate how much you made.

Speaker 1

That's not make money. I can use them. I can use them to buy stuff. Whatever, get free money.

DAN



Xia, I've seen you get checks for like \$500. You would have to buy thousands of dollars worth of stuff to get \$500 back.

Speaker 1

So, I can help some people doing that and then I get the, I get some free money, you don't have to report to the tax.

DAN

I'm telling you Xia they are going to look at everything.

Speaker 1

Yeah, let them look at everything. I will tell the thing to my lawyer.

DAN

And they are not going to believe you and your lawyer is not a defense attorney.

Speaker 1

It doesn't matter.

DAN

It does matter a lot.

Speaker 1

It doesn't matter you don't need to say some bullshit to me. And then you sign my name to get the tax reward.

DAN

Yeah, you can look that up too.

I'm happy they check everything.

DAN

Good

Speaker 1

Look at that shit too. You try to. How much money spending. That's make me hurt. Make me angry. How much you spend to the vet, how much you spend for me, and then you use the money against me.

DAN

Use what money against you?

Speaker 1

You are not human Dan, you're not human.

DAN

Xia, how about we just don't call people names and just have a normal conversation? Ok? I haven't said anything bad about you. I'm just telling you what they're going to be looking for.

Speaker 1

Yeah, tell them looking for it. Tell them look.

DAN

I don't have to tell them, that's what they do. That's their job.

Speaker 1

Yeah, tell them to do it.

DAN

I don't have to tell them.

Speaker 1

\$9.00. \$9.00? I take from buy stuff \$9.00? Oh my god.

DAN

Xia, you can give the stupid examples, but you're not talking about the big stuff that is there.

Speaker 1

It doesn't matter the rebates is not called doing business. To do that I can tell anybody .. I can say "Ok, can you help me order some stuff" Ok order some stuff I don't get some money from you, but I will use that website to do.. get some

DAN

Yeah and nobody is going to believe that.

Speaker 1

Get some money from there.

DAN

Nobody is going to believe that because you bought the same thing that you bought when you did business.

Speaker 1

I don't need telling me.. I don't need you to say somebody don't believe it. I need the truth. The truth is the \_\_\_ account is my account , how much in my account? That's them doing it to see the truth. Where's the money?

DAN

Just because you give all your money to your brother and sister doesn't mean it's not you making it.

Speaker 1

Where's the money in there? Does my account have money? That's the truth.

DAN

No, that's not the truth.

Speaker 1

Yeah that's the truth. Where's the money. How much money in my account? You can see it. Mouth say its not true.

DAN

Xia, it's not by my mouth.

Speaker 1

It's not by your mouth saying it's true.

DAN

Great, I'm telling you, it's going to be hard for them to believe it.

Speaker 1

Yeah you don't tell me. I'm telling you, you tell me for 7 years, 7 years you have affair and then you threaten me, if you tell my boss and I get fired. And have no money to give Max.

DAN

Why would I say anything to your boss?

Speaker 1

You say the thing and threaten me all the time.

DAN

I'm not threatening you at all.

Speaker 1

God damn go to do it. I'm happy that you do it. I'm going to clean my \_\_\_\_ . I'm happy that you do it. I asked to fucking ask to checking it. See I only have money in my bank account.

DAN

It's not about your bank account.

Yeah, my bank account see any money in there.

DAN

Xia, it's not about your bank account.

Yes. That fucking business open the account it's not just mine I don't get any money from them. I don't. Even my parents even give me the gift money. I didn't even be a crime yet. It's not a crime yet how much you own that I fucking asked my friend she's a CPA. Said you owe a lot of money for the tax, just pay the tax. Punish, it's not a crime.

DAN

No, it depends.

I'm not trying to blame you or threaten you. It is a crime.

It depends on how much money it is

Yeah it depend ... doing it doing it.

DAN

So it is a crime.

Doing it, it's not a crime. Stop saying the shit to me. I don't listen to say the shit to me. Say the shit to me for so many years say it's a crime.

Xia, I didn't lie to you at all.

Yeah you didn't lie to me of course you lie. You didn't know anything. You fucking think about I make a lot of money. The fucking thing is the money buy it and ship out stuff and didn't make fucking shit any money.

You're still not listening. I don't care what your excel says. Nobody cares. They're going to look everywhere else. Nobody is going to look where you tell them to look. They're going to look where you're not saying.

Yeah saying.. look at the Chinese

Speaker 2

I'm trying to tell you. They can look at the Chinese ATM.

Yeah the Atm is the fucking money account come from who?

Speaker 2

It doesn't matter who it came from. It matters who it went to.

Yeah, the gift money went to?

Speaker 2

Went to you.

Speaker 1

Went the gift money.

Speaker 2

And they are going to believe that because you're still buying products.

Speaker 1

So, even its make money or no, it's my parents support me.

And you're still shipping products.

Speaker 1

Even shipping money I don't get reward, go and check it for this year see any ....

Nobody is going to believe you get nothing for all that.

Speaker 1

It doesn't matter believe, not believe, that money is come from my parents. I don't care. I don't care so I can live, not die, my husband don't give me any money. Now he don't give me any money. Never give me any money.

How about my rich wife doesn't help pay the bills.

You don't give me any money.

How about my rich wife doesn't help pay the bills?
